

-FY2015 • 2 grant cycles per year


 Criteria: developed and posted grant criteria that were approved by Ministers

Timeline: SAC Grants Process, cont.




- Single grant cycle

 Financial Information: required applicants to submit their Form 990s or an organizational budget to provide a basis for assessing their need for a grant



Assessment Criteria

Criteria for Assessing Giving Models

- Total amount given
- Types of grantees (small, medium, and large grants)
- Breadth of grantees to support
- Ability to evaluate/vet grantees
- Effort to administer
- Continuity of relationship with grantees
- Flexibility to respond to unexpected needs
- Ability to involve members
- Congregation opinions

Data Collection

- SAC Grant Data
- First Parish accounting records of SAC Reserve
- Survey of Congregation
 - Standing Committee Open House Discussions Fall 2017
 - 4 sessions with 2 10 attendees over four weeks
 - Standing Committee Congregational Survey February 2018
 - Paper survey on STP distributed before service and collected after service.
 - Sunday March 14 46 responses
 - Survey of SAC Grant Sponsors from past five years
 - Last 2 weeks in March 9 responses

SAC Grant Allocation Criteria


Eligibility Criteria

- Sponsored by a pledging member
 - Sponsor may not be a staff person of the organization
 - SAC Allocation Team members may not sponsor an application
- Not required to be a 501©3
- May not be a scholarship
- May not support First Parish social action activities

Selection/allocation Criteria

- Goal of the project specific, attainable and realistic
- Desirable:
 - the project provides seed money and support new ideas or a new project
 - the project includes or will create opportunity for significant First Parish connection and participation
- Amount of grant will make a meaningful contribution to project's success
- Seek a balance between local, regional, national and international projects
- SAC Allocation Team members excuse themselves from decisions on any organization with which they have a direct association.
- We document our rationale for the decision on each application.


SAC Grants 1968 through 2018



Total SAC Grants: FY2003-FY2018








SAC Grants: FY2014-FY2018

Many Grantees receive grants regularly

- First Parishioners have sponsored applications for 38 different organizations
- 7 organizations received grants in all 5 years
- Over half (20) received grants in 3 or more years
- 4 applicants did not receive a grant

Applicants by Number of Years Received Grants





SAC Grants: FY2014-FY2018

Most grants are \$2,000 or less

- Two-thirds of grants averaged from \$1000 to \$5000 over the five year period.
- The UUUM receives the largest grants
- Some applications request or receive several hundred dollars.



SAC Reserve

- Any unspent balance of the 7.5% was put into a reserve fund, and remained available for future expenditures.
- The 2010 peak reflects payment of the SAC Director's position from the regular budget.
- The 2017 peak reflects the vacancy in the SAC position.



SAC Grants Compared to Share the Plate

Criteria for Selection of Share the Plate Pilot Recipients


Eligibility Criteria

- Nominated by a First Parish program or a pledging member/s
- Mission consistent with UU principles
- Non-profit (501c3) status
- Likely share of collections would make a meaningful difference to the organization

Selection Criteria

- Extent of support from the congregation (# of nominating sponsors, # of FP programs nominating, opportunities for generating matching funds)
- Opportunity for congregants to build a relationship with the recipient organization (opportunities for partnership, volunteering, or further fundraising)
- Selecting recipients to contribute to a variety of local, national, and international target populations and to different social justice missions
- Opportunity to align collections with themes of sermons and social action events
- Degree to which collection would support the priorities of the UUA

SAC Grant Sponsors Have Concerns About STP

- It is a lot of effort and work to plan an STP with possibly reduced financial returns.
- The exposure to the congregation during the STP period will likely increase the FP Congregation's awareness of the organization, but it is unclear if the financial return will also increase.
- The goal should not be so focused on increasing FP's plate collections, but, on the organization needing the funds and exposure.
- To do Share the Plate effectively there needs to be an information sheet in the order of service about the group. It should also be in FP Announce and in the MHN.
- I am surprised to learn ... how few people understand the need right here in Concord. I hope that we continue as an organization and a church to address the stigmas that are alive and well - figuring out how we as a church create a compassionate place to worship and care for others within.

Ability to evaluate/vet grantees

- SAC Grants are designated for specific purposes
 - Cover sheet and 2 page narrative
 - Form 990 or budget which helps to better assess the likely impact of the grant requested
 - Accountability grantees report on accomplishment of goals

STP Collections are unrestricted

- Cover sheet and 2 brief questions
- We check 990s when they have been posted publicly not available for all organizations
- Most congregants (87%) say that they received enough or very complete information
- But they wanted more information in multiple formats
- Both processes involve a group of parishioners considering and coming to consensus on which organizations best meet explicit selection criteria
- The limited information available in these selection processes is not sufficient to fully vet the quality of potential recipients

Effort to administer

SAC Grants process has become burdensome

- Application process could be done less than annually for organizations that are well known to First Parish
- STP requires more of the sponsor and nominee, and less of the SAC Board
 - Sponsors complete a brief nomination form the organization may not be involved ahead of time
 - But nominees will usually be more involved with the congregation through a visit during or after the collection period

Data collection and record keeping can be simplified

- Use Survey Monkey to collect contact and summary information, automatically creating the database needed for recordkeeping and generating and sending checks
- As STP develops, we should consider how to build transparency into the selection process

Continuity of Relationship with Grantees/Recipients

SAC Grants

- Many organizations apply every year and count on some First Parish support
- Larger organizations, like Household Goods and Gaining Ground, have been weaned off FP support over a year or two

Share the Plate

- Pilot period will have unique recipients for at least 2 years
- We don't yet understand how collections will run over time and whether organizations will feel that STP is worth the effort
- High collections so far have rested on a few large individual donations

Flexibility to Respond to Unexpected Needs

SAC Grants

- Single application period
- Have used reserve to match special collections for disaster relief
 - With the reserve spent down, there will be less ability to match collections

Share the Plate

- Anticipated to be conducted throughout the year
- Expect to select recipient organizations at least 6 months ahead of time
- Could leave some months open or change schedule to respond to unexpected needs


Congregational Feedback

Congregation Opinions

Open Houses found

- First Parish community strongly supports social action, defined broadly to include:
 - ▶ activities,
 - grants, and
 - relationships to our own and other social action organizations.
- And it wants more Social Action
- There is support for a Social Action Coordinator
- However, there was concern about the 7.5% allocated to SAC grants.
 - Administrative burden
 - Having the 7.5% outside the operating budget is a governance issue.

Congregation Survey Preferences for SA Funding



Change SA Funding:

Eliminate 7.5% of pledges social action allocation. Move Coordinator and budget to regular FP programs. Coordinator, in consultation with SM, SAC Board, and parishioners administers budget to support social justice efforts which may include grants.

Partial Change #2:

Reduce portion of 7.5% to fund Coordinator's salary, keep remaining amount to fund Social Action Grants only.

Partial Change #1:

Retain 7.5% of pledges to go only to Social Action Grants. Coordinator position may be eliminated unless money is found in budget.

No Change:

Retain 7.5% of pledges to Social Action to be where part us used for Coordinator's salary and part is used for Grants.

Ability to involve members

SAC Grants

- Opportunity for congregation to review applications is important for transparency, but very few members do review the applications.
- Approximately 9 readers have participated over the past 5 years, but it takes considerable effort to summarize and use their input.
- Many grantees have deepened volunteer commitment or had more volunteers participate
- Grantees also report that being a grantee has increased awareness of their program and the issues they address
- However, this can probably also be achieved by STP

STP

- Funds come directly from parishioners, who can decide how much to give
- Our survey found very positive feedback on STP
 - It is a good idea
 - I really like share the plate
 - I love this idea Please update us on how much is raised
 - Well done. Meaningful part of the service.
- 68% of respondents indicated that they might or would nominate an organization for STP

Preliminary Conclusions

Preliminary Conclusions

- The strengths of the SAC grant process should be carried forward
 - Transparency
 - Group decision making process
 - Opportunity for comments from congregation
 - Using Form 990s to assess where our resources can make most difference
 - Accountability for consistently applying selection criteria
 - Finding a balance in supporting a variety of social justice goals
- > Share the Plate has been well received by the congregation and will likely succeed in
 - increasing congregational involvement in Social Action giving
 - increasing awareness of the organizations involved and the issues they address
 - continuing to help organizations recruit volunteers and deepen their commitment
- STP is not currently planned to allow for annual giving
 - Organizations like Open Table, Concord Prison Outreach, and UUUM would be among those most affected
- The commitment of 7.5% of pledges ensured a certain level of First Parish giving
 - The long term ability of STP to raise equivalent or more funds than what has been given through pledges is not yet known.
 - First Parish should set a goal for social action giving that is equal or exceeds what has been given through SAC grants, and adjust its methods for giving until the goal is reached
 - These data on SAC giving can provide a baseline for evaluating future funds given
