# **Minister Report and Update**

Seth is getting acclimated to his new role as Interim Senior Minister, having now been at the church for a little over a week. He is looking forward to working with First Parish. Seth will first preach on August 28<sup>th</sup>.

# **Operations Update**

• First Parish received a restricted gift of \$5,000 for the Social Action Committee's Social Action fund.

Upon motion duly made and seconded, it was unanimously **VOTED**: to accept the restricted gift of \$5,000 for the Social Action fund.

- Fifi sent a year-end financial report prior to the meeting. She stated that the year-end turned out better than she anticipated. She thought we would end at approximately -\$74,000, and in the end we were at approximately -\$11,000.
- Budget for church year 2022-2023 (FY 23)
  - Gib, Jim H., Jim R. and Heather are the members of the Financial Sustainability
     Subcommittee. They described a 4-step process to reach financial sustainability:
    - 1. Close the gap in this year's budget due to the fact that we budgeted \$970,000 in pledge income, but we actually only received \$925,000 committed pledge.
    - 2. Make sure that the FY24 budget will be balanced.

- 3. Plan for sustainability of future budgets in years when the Simmons gift (\$1,000,000 given in FY22) is no longer available.
- 4. Do some long-range planning and strategizing to address the risk of losing a big donor upon whom we depend.
- Liz stated that we will need to get feedback from the congregation on: (i) how to handle the current shortfall for FY23; and (ii) what choices should be made about FY24 budget (e.g., do we want to cut programs, increase pledges, etc.).
- Heather stated that we will need a strategy for communicating about finances with the congregation, in conjunction with the communications subcommittee.
- Susan stated that we should strategize with the pledge committee about when and how
  to communicate with the congregation about money. She suggested that we run a few
  small fundraisers. Jen mentioned that it may be time for another auction.
- Jim mentioned that in Howard's Exit Interview, Howard observed that we are reluctant to ask fellow congregants for money.
- Mike said the Standing Committee or Pledge Committee should call people who haven't given as much now as they did in the past to understand why they are pledging less.
   Mike volunteered to develop interview questions for such conversations.
- Liz suggested that conduct a congregation-wide survey this year. In addition, each of the 3 SC subcommittees should coordinate their milestones and proposed communications to the congregation.
- Liz said we should think about whether we have the right committees and groups in place to achieve financial sustainability. Who will actually do the work needed?
