Responsibilities of the Governance Subcommittee include:

- 1. Ensuring that the SC adheres to written policies and procedures.
- 2. Reviewing all policies and procedures at least once every three years.
- 3. Proposing new policies and procedures when needed.
- 4. Reviewing bylaws periodically and proposing revisions when needed.
- 5. Supporting the creation of SC goals and monitors progress towards those goals.
- 6. Ensuring the SC conducts a yearly self-evaluation.
- 7. Remaining alert to identifying and promoting best practices.

Ministerial Support Subcommittee – Jeff, Peter, Dave

Responsibilities of the Ministerial Support Subcommittee include:

- 1. Providing support to the Senior Minister
- 2. Working in conjunction with the Senior Minister on goal setting
- 3. Clarifying respective roles and responsibilities of Senior Minister and Standing Committee.
- 4. Reviewing Senior Minister compensation annually
- 5. Reviewing Senior Minister contract as contractually required.
- 6. Ensuring Senior Minister evaluation.

Finance Committee – Jane, Treasurer; Tom, liaison; Sue Wood, Nan Jeffries, John Caffrey, members

- 1. Determine if there will be a capital campaign and how we might support it
- 2. Participate on the Wright Tavern Committee
- 3. Explore how to diversify our donor base

The primary responsibilities of the Finance Committee will be:

- To assist the Standing Committee and Treasurer to identify congregational priorities in support of the budget development process, by organizing and facilitating congregational discussions and compiling priorities for consideration by the Standing Committee, Treasurer, Head of Staff, and Director of Operations;
- 2. To assist the Head of Staff and Standing Committee to communicate budget alternatives to the congregation, by organizing and facilitating congregational discussions and compiling feedback for consideration by the Standing Committee/Treasurer and the Head of Staff/Director of Operations;
- 3. To be available to provide ad hoc financial and technical expertise to the Treasurer and the Director of Operations, and to take on special projects requiring financial expertise.
- 4. The Standing Committee may ask the Finance Committee to explore mechanisms for improving the financial capacity of First Parish.
